Course Description

The course provides a comprehensive and practical introduction to the theology and practice of discipleship, particularly in and through the local church. It is designed to prepare pastors and church leaders in fostering the discipleship and equipping of individuals and of the congregation as a whole. The course focuses on the nature of congregational life and how it impacts the type of discipleship and missional texture it promotes. Further, there is attention to the change process associated with moving a congregation into a new direction.

Course Objectives

Upon successful completion of this course, students will be able to:

- Be familiar with some of the best current representative works in the field of discipleship.
- Articulate a theology of discipleship and spiritual growth that is faithful to Scripture in content and consistent with our larger historic evangelical heritage across the centuries.
- Grow in the understanding of how discipleship is impacted by various social sizes.
- Gain skill in understanding the context for implementing plans of discipleship in the local church, by creating discipleship curricula.

Course Modality

This course is offered online at flourishmovement.org. This online course has a fixed start and end date with scheduled weekly Lessons and associated Assignments and Activities. Although this course is primarily asynchronous (meaning that students usually do not have to be online at certain times to complete course requirements), students will need to adhere to weekly due dates. In addition, students will have to be present for four (4) web meetings scheduled by the Instructor. There are also four assignments that require students to work with a partner via email and/or Zoom. More information can be found within the course site.

Those taking the course for personal enrichment are strongly encouraged to stay on track with the schedule for credit-seeking students. Access to course content is not guaranteed after the course end date.

Course Schedule

The course is organized into eleven content weeks called “Lessons,” one holiday week, and two additional weeks focused on completing major summative assignments. Weeks begin on a Tuesday and end on a Monday.

Course Requirements

I. Readings and Reading Reports

Students are required to obtain and read several books for this course. Books can be obtained through the [Gordon-Conwell Charlotte Bookstore](#) or any online retailer. Weekly reading assignments are posted in the course site. Students are required to complete the readings to pass the course and will submit a course report on March 23 (mid-term report) and at the end of the course attesting that they have completed this requirement (and others). It is best to try to write your report weekly to stay current.

Students may choose to read half of the books if they choose a reader partner who will read the other half. If this joint option is chosen they each team of readers will meet weekly for 30 minutes on-line or by phone to discuss what they learned from their reading. For these joint readers there will be a joint reading report turned in with an additional paragraph of what the non-reader learned from the reader. (note – both persons will read the Allin book and take the assessment provided)

There is also opportunity for you to indicate substitute or extra reading in consultation with the instructor.

The texts provide a practical foundation for the ministry of evangelism and discipleship in a local church. My desire is to entice you to a life-long love of reading in these fields.

Each student will write a **Reading Report** for each work read, first describing the **central thesis** of the book (usually one or two paragraph), followed by a critical analysis of what in this book was helpful in crafting your ministry (two paragraphs).

Due dates for Reading Reports are located in the course site.

II. Lectures

Students are required to watch weekly lecture videos. These videos are posted in the course site. Students are required to watch all of the lecture videos to pass the course and will submit a course report at the end of the course attesting that they have completed this requirement (and others).

III. Activities and Assignments

Students will complete various activities and assignments associated with the content of the Lessons. For four of the assignments, students taking the course for credit (whether taking for CLP credit alone or those taking it for both CLP and Gordon-Conwell credit) will work with a partner via email and/or Zoom. Instructions and due dates for all the activities and assignments can be found within the course site.

IV. Web-Meetings with Instructor

There are four web meetings during the semester (60 minutes) with the Course Instructor to discuss course content, learnings, and your projects. Meeting dates are provided at the top of the syllabus. A meeting verification will be required at the end of the course.

V. Four Week Discipleship Project

To experience discipleship during the course, each student will lead four sessions of discipleship with two younger believers. You will need to recruit two people willing to be your practice partner for 4 weeks. I suggest that you disciple the two in a group together with you (1 on 2). You will all study the book of Philippians and do one chapter per week. An alternative would be to do any four chapters in the Ogden book. Write a one-page reflection after each discipleship meeting and turn them in together as a summary of the project. Full descriptions of this project, including due dates, can be found in the course site.

VI. Project/Final Paper

In lieu of a final exam, students will complete a written project that provides the student with practical experience in shaping a culture for discipleship. Start assembling ideas for this project from day one.

Detailed instructions are available in the course site.

VII. Course Reports

At the end of the course, students will complete a Course Report verifying completion of all non-graded activities including reading, lecture viewing, and class web-meetings attendance.

Assignment Formatting and Submission

Writing assignments should be submitted as either a Microsoft Word document or PDF file in the course site (email submissions are not accepted).

All assignment file names should follow this convention:

All written assignments should be double-spaced with one-inch margins and a 12-point standard font and **should follow the most recent edition of Turabian (Chicago Style for Students and Researchers) for paper formatting and citations.**

- CT490 – Writing Skills Workshop. CT490 is a one-credit-hour online refresher course that introduces seminary students to essential grammar and composition skills necessary for pursuit of graduate-level writing.
- CT500 – Introduction to Theological Research and Writing. CT500 introduces students to graduate-level research and writing skills with specific attention to academic writing, theological research, integrating sources, understanding and avoiding plagiarism, and the proper citation of sources following the Turabian style manual.
